Newman Aguiar is owner of Mowbot of the Triangle, which provides robotic lawn mowing services. Along with his wife Ann-Louise, and 19-year old son, Joshua, they enjoy being part of the inclusive and welcoming St. Philip's community, and appreciate its focus and action on social justice in downtown Durham. Members of Christ Church in Raleigh since 1995, Newman completed his Education for Ministry (EfM), a four-year certificate program in theological education based upon small-group study and practice.
