- Migrating to Realm will be very helpful but will require some work on the front end to get data cleaned and ready for migraine. Suggestion to create a committee to support the migration and launch of the new tool.
- Vacation terms have not been consistent. The Episcopal Church is supporting benefits parity. Personnel committee is recommending that clergy and lay persons receive the same benefits to be in line with the intent of the parity policy.
